# Estonian Junior Tour 2024, II (Rae Golf) Local Rules

## 1. Out of Bounds (Rule 18.2)

- (1) Out of bounds is defined by the line between the course-side points at ground level of white stakes.
- (2) White stakes defining out of bounds are deemed to be boundary objects (Rule 8.1a).
- (3) The ball is deemed to be out of bounds when it comes to rest on a closely mown area of the general area of the 12th hole when playing the 11th hole and on a closely mown area of the 16th hole when playing the 17th hole (Rule 18.2a).

#### 2. Distance markers

(1) Distance marks to the centre of the green: white – 200m, yellow – 150m, red – 100m.

## 3. Abnormal Course Conditions (Including Immovable Obstructions) (Rule 16)

- (1) Immovable obstructions are all distance markers on a fairway, all roads, even if not artificially surfaced, benches, information boards at tee areas, ball washers, clocks, all sprinklers, drainage grates, lamps on the 18th green island, the wooden path in the 18th hole bunker, and utility boxes (Rule 16.1).
- (2) Ground under repair is marked by blue stakes and/or painted line. When both stakes and line are used, marking line applies (Rule 16.1).

# 4. Penalty areas (Rule 17)

(1) Penalty area is marked with red markers and/or painted line. When both markers and line are used, marking line applies.

## 5. Movable obstructions (Rule 15.2)

(1) Penalty area stakes, stakes connected with rope or chain, Next tee signs

### 6. No Play Zones

- (1) No Play Zones are marked with the corresponding sign and/or blue and white stakes. The player must take mandatory relief (Rule 16.1f).
- (2) Trees and plants supported by a bamboo stick or marked with a blue ribbon or spray are deemed to be in No Play Zone and play from the area of interference with the player stance or intended swing is prohibited. The player must take mandatory relief (Rule 16.1f).
- (3) The opposite bank of the ditch located in the right-hand side penalty area of the 1st hole and the area beyond it, including the road, are deemed to be No Play Zone (Rule 17.1e).

#### 7. Preferred Lies

- (1) Model Local Rule E-3 Preferred Lies Rule. A ball in the general area, cut to fairway height or less, may be lifted, cleaned, and placed once within one open score card of the ball's original spot on the general area without penalty, but not nearer the hole.
- (2) The ball must be placed in accordance with Rule 14.2b(2) and 14.2e.

### 8. Temporary Immovable Obstructions (TIO)

(1) Model Local Rule F-23 Temporary Immovable Obstructions is in effect. TIO is a structure that is temporarily added on or next to the course, usually for a particular competition, and is fixed or not readily movable. TIOs include any supporting guy wires connected to them. The outermost edge of the TIO is used in determining whether a ball is under the TIO or whether the TIO is on the player's line of sight between the ball and the hole.

Breach of local rules is a general penalty (2 strokes penalty in Stroke Play or loss of a hole in Match Play).

### Filling in the Electronic Scorecard

The player(s) are required to fill in the electronic scorecard. The players in a starting group can mutually agree on who will enter the scores of all players in the starting group into the electronic scorecard. If the player(s) fail to fill in the electronic scorecard after repeated reminders, the competition committee may refuse to register the player(s) for the next stage(s) of the competition.
